Sutler Guidelines

Saturday and Sunday January 6th & 7th, 2024 Bushnell, Florida

The Dade Battlefield Society and Dade Battlefield Historic State Park invite you to the 43rd Annual Reenactment of this Second Seminole War battle as a sutler. This living history reenactment weekend will include:

- > Full scale battle on Saturday and Sunday
- ➤ Historical Period Soldier, Seminole and Civilian Camps
- Sutler Trade Fair
- Historic arts and crafts demonstrations
- ➤ Early 19th century games for children
- > Full scale cannon firing
- > Tree cutting and barricade building

Dade Battlefield Historic State Park is in Bushnell, Florida Just east of I-75, exit #314 Approximately 50 miles west of Orlando, 50 miles northeast of Tampa, and 40 miles south of Ocala

GENERAL GUIDELINES FOR THE DADE BATTLE REENACTMENT

The Dade Battlefield Society is continuing its multi-year program to improve the authenticity of our annual event and help to significantly increase the number of quality participants, period sutlers and attending public. The most important aspect of sutlers associated with the Dade Battle is authenticity to the time period. Sutlers must be accepted to attend and all applicants will be juried. Approvals of new applicants will be based upon submitted photographs of the applicant's set up, trade goods and person in period attire. In addition, and for the sutlers' benefit as well as that of the event, the approval board will not accept an excessive number of sutlers selling the same type of wares.

The time period for this event is December 1835. Your dress, manners, camp and behavior must reflect this time period without exception during the public hours of the event.

FEES, DEFINITIONS AND MEALS

- > **SUTLERS** period campers with tables, display racks or anything other than a blanket to display their wares. Persons with a trade blanket but no period camp of their own are considered sutlers and are required to set up in the sutler area.
 - o A non-refundable \$50 sutler fee is required.
 - Sutlers, spouses, family members or associates of sutlers may purchase four (4) provided meals for \$25 per person. Meal tickets must be purchased during registration at the park.
- ➤ **BLANKET TRADERS** MUST be a Seminole or Soldier battle participant and must display the trade goods on a blanket in the camp area.
 - Blanket traders are considered participants and will receive free meals. Spouses, family members or associates of blanket traders that are not registered as participants may purchase four (4) provided meals for \$25 per person. Meal tickets must be purchased during registration at the park.
- **DEMONSTRATORS** pre-approved working participants who will be crafting period items on site and will commit to either demonstrating their craft to the public constantly during the public hours or according to a pre-approved set and published schedule.
 - Demonstrator status is not given to someone whose main purpose for attending the event is to make sales. Demonstrators may make incidental sales ONLY of the items/ type of items they are crafting. There are no exceptions. Demonstrators who wish to sell more than the items they are crafting must be registered as a sutler.
 - Demonstrators are considered participants and will receive free meals. Spouses, family members or associates of blanket traders that are not registered as participants may purchase four (4) provided meals for \$25 per person. Meal tickets must be purchased during registration at the park.
- ➤ **PERIOD MUSICIANS** considered demonstrators if they have no store and perform throughout the public hours. Musicians will be pre-approved by the sutler/vendor coordinator who will also designate their performance site.

CLOTHING AND APPEARANCE

Period civilian attire of an Eastern US nature. No mountain man or Western influenced clothing (fringed jackets, cowboy hats or boots, dusters) is permitted. Period attire does not include Colonial or Civil War era clothing- this is an 1830s event. Eyewear must be 19th century- no modern eyeglasses. No modern jewelry or watches. No cigarettes are permitted during public hours- period pipes or hand rolled cigars only.

TRADE GOODS

Trade goods must be authentic to the time and place. Hand made goods of the 1830s and earlier are encouraged.

The Sutler Coordinator and Florida Park Service staff will be inspecting period sutler area. Unauthorized items will need to be removed and stored out of public view.

You may not sell modern goods, flea market items, Plains Indian items, Pow Wow goods, Civil War or Victorian goods and obvious modern imports (oriental knives, bullwhips, and Mexican serapes), or *artifacts removed from historic battlefields*. An exception for modern goods may be made for period music CDs and cassettes but special display rules will apply. No black powder or rolled cartridge sales per ATF rules.

Souvenir items may not be sold- Souvenirs include, but are not limited to the following items: bumper stickers, t-shirts, ball caps, non-period toys, comic books, etc.

Sales to minors- Knives, pistols, tobacco products and other inappropriate items may not be sold to minors.

SALES TAX

All retail sales in the State of Florida require a State Sales Tax Certificate. You must collect taxes on all sales and forwarded them to the Florida Department of Revenue. You may obtain information about the State Sales Certificate by contacting the Leesburg Service Center office of the Florida Department of Revenue at (352) 315-4470.

SET-UP AND PARKING

Store tentage should be period correct for the time and place. All non-1830s items must be kept out of sight of the public including food packaging, coolers, drink containers, modern bedding, etc.

Sutlers may set up on Friday, January 5, 2024, from noon to dark. All vehicles must be removed from sutler area before gates open at 9:00 am on Saturday. Early morning hours on Saturday are for those who have last minute preparations that were not able to be attended to the evening before due to darkness. Sutlers will keep their vehicles in the designated parking area at night and during public hours. Anyone wishing to set up earlier than Friday, January 5, 2024 must email reenactment@dadebattlefield.com prior to December 22, 2023. Anyone wishing to stay over until Monday, January 8th, 2024 needs to contact the park office at (352) 793-4781 by December 1, 2023.

OTHER DETAILS

FIRES: Sutler area campfires MUST use fire bricks to prevent scarring of the ground in the park's Day Use Area.

SUTLER CAMPING: There is no electricity provided. Sutlers will be able to park near the Gardiner Pavilion and Day Use Restroom area.

PARK GATE: Open until 8:00 am Saturday then closed to vehicular traffic until 5:00 pm and will remain open until 8:00 am Sunday morning then closed to vehicular traffic until 5:00 pm. Arrivals after 8:00 am on Saturday & Sunday need to use back gate to park located on CR 650.

REGISTRATION HOURS: Friday 1:00 pm to 5:30 pm

Saturday 7:00 am to 5:30 pm Sunday 7:00 am to 9:00 am

USE OF PARK FACILITIES: We request that you refrain from using restrooms when the "Closed for Cleaning" sign is across the day restroom entrance and signs are posted on lodge restroom doors. If the facilities start to back up or you experience problems, please notify park personnel so these problems can be addressed and fixed. Day Use Restrooms will be opened from 6:00 pm to 7:00 am each day of the event.

Lodge will remain opened for the use of restroom facilities and for a gathering place for participants to socialize and work on period clothing. Quiet time is midnight to 6:00 am.

Pets: Allowed if on a 6-foot leash and must be tended to at all times. Owners will be responsible for picking up after their animals.

Lodging: For those needing other accommodations for the weekend we have compiled a list of nearby locations. We have no partnership with these accommodations and this list is provided as a courtesy.
